## **TERMS & CONDITIONS**

## cinch Park & Charge at Latitude (20-24 July)

These are the terms and conditions ("Terms") that apply to cinch Park & Charge. No spaces available on the day and all spaces must be booked in advance. Places are limited and not all applicants will be successful in securing a parking spot.

- 3. If you are successful in booking your free parking spot, you will receive a confirmation email and QR Code which will act as your ticket to the car park. Without your confirmation email and QR Code you will not be allowed to park your car. Cinch accepts no responsibility for any lost, damaged, corrupted emails or QR Codes or the unavailability or disruption of any website, app or ticketing platform.
- 4. If you are not successful in booking your free parking spot, you will receive an email confirming that you have not been successful and will be put on a waiting list.
- 5. Eligibility: Entry is open to legal residents of United Kingdom who are at least 18 years old at the time of entry, have an electric car and who have a valid ticket to Latitude 2022. The Offer is not open to employees and contractors of Cinch, any of its group companies or their families and households and anyone else professionally involved or associated with this offer. Cinch reserves the right at any time to require proof of eligibility in such form as Cinch reasonably considers necessary.
